New Business:

Orchard Associates, sign review 2012-003

Planning Consultant, Chris McLeods' review dated August 10, 2012 was entered into public record.

Sandra Lackey-Jarvis on behalf of the applicant stated that the sign itself is not illuminated but presented the commission an updated sign diagram with the addition of text indicating the intent to light in the future with LED flood lights from below. Commissioner Lackey-Jarvis also noted to the remaining commissioners her wish to abstain from the vote with a conflict of

interest.

Discussion amongst the commission followed. Commissioners noted that no one from Orchard Associates appeared before the planning commission in regards to the application.

Motion by Commissioner Ewing, support by Commissioner Cady to approve the proposed sign application as amended with the stipulation that any future flood lighting does not exceed 100 watt incandescent flood or the LED equivalent. A roll call vote was taken: Ewing; yes, Cady; yes, Roodvoets; yes, Lackey Jarvis; abstain. All in favor (3); abstain (1, Lackey-Jarvis).

Chairman Roodvoets declared the proposed sign approved.
