**Resolution of Intent  
Opposing Incorporation as a Charter Township**

**WHEREAS**, the Township Clerk has been notified by the Secretary of State of the State of Michigan that Lapeer Township has a population of 2,000 or more inhabitants, excluding the population of any incorporated village, and notice of that notification was duly published in the County Press newspaper, a newspaper of general circulation in the township, as required by law, and

**WHEREAS**, under the provisions of MCL 42.3a, the Township is eligible to be incorporated as a charter township by resolution of the Township Board, and

**WHEREAS**, after notification is received by the clerk, the township board may adopt, by a majority vote, a resolution opposed to incorporation, and

**WHEREAS**, the Township Board does not desire to incorporate as a charter township,

**NOW, THEREFORE**, in consideration of the foregoing, **IT IS HEREBY RESOLVED** that the Township Board does hereby declare its intent to not incorporate Lapeer Township as a charter township.


PUBLIC TIME:


