ESTABLISHMENT OF RECEIVING BOARD: R-008-12:

Township of Lapeer Establishment of Receiving Board

WHEREAS, Michigan Election Law (Act 116 of 1954) provides in MCL 168.679a that the legislative body of a city, township or village may, by resolution, provide that one or more additional boards of election inspectors be appointed to serve as a Receiving Board of election inspectors at an election at which the ballots are counted and certified at the precinct; and

WHEREAS, the Election Commission shall appoint a Receiving Board consisting of not less than two election inspectors, with an equal number of election inspectors from each major political party; and

WHEREAS, not less than two election inspectors in a precinct, representing each of the major political parties, shall deliver to the Receiving Board for that precinct in a sealed transfer case, election materials as stated Michigan Election Law; specifically MCL 168.679a(2); and

WHEREAS, the Receiving Board will be responsible for the duties as outlined in MCL 168.679a of the Michigan Election Law (Act 116 of 1954) and the guidelines as set forth by the Secretary of State Bureau of Elections; and

NOW THEREFORE, BE IT RESOLVED that the Township of Lapeer Election Commission is authorized to establish a Receiving Board for each election beginning with August 2012.

GENERAL APPROPRIATIONS ACT - BUDGET R-009-12:

Lapeer Township General Appropriations Act Fiscal Year 2012-2013

A resolution to establish a general appropriations act for Lapeer Township; to define the powers and duties of the Lapeer Township officers in relation to the administration of the budget; and to provide remedies for refusal or neglect to comply with the requirements of this resolution.

The Board of Trustees of Lapeer Township resolves:

Section 1: Title

This resolution shall be known as the Lapeer Township General Appropriations Act.

Section 2: Chief Administrative Officer

The Supervisor shall be the Chief Administrative Officer and shall perform the duties of the Chief Administrative Officer enumerated in this act.

Section 3: Fiscal Officer

The Clerk shall be the Fiscal Officer and shall perform the duties of the Fiscal Officer enumerated in this act.

Section 4: Public Hearings on the Budget

For general law townships: Pursuant to MCLA 141.412; MCLA 141.413, notice of a public hearing on the proposed budget was published in a newspaper of general circulation, being the LA View Newspaper on May 03, 2012; and a public hearing on the proposed budget was held on Monday, May 14, 2012.

Section 5: Estimated Revenues

Estimated Township General Fund revenues for fiscal year 2012-2013, including an allocated millage of 1.6072 mills; and various miscellaneous revenues shall total \$ 719,375.00.

Section 6: Millage Levy

The Lapeer Township Board shall cause to be levied and collected the general property tax on all real and personal property within the Township upon the current tax roll an amount equal to 1.6072 mills as authorized under state law and approved by the electorate.

Section 7: Estimated Expenditures
